## Program Overview

- Started in November 2016
- Partnership between HOST, Parks & Recreation, DOTI, Bayaud Enterprises, and others
- Entering 6<sup>th</sup> program year in 2022

Denver Day Works is a supported work program designed to provide a low- to no-barrier work experience for people throughout the city who are experiencing homelessness, while also connecting participants to supportive services such as food, shelter, and other necessities.

- **Same-day work experience** to individuals experiencing homelessness and not actively engaged in day program services
- **Coordinate and supervise work experiences** at approved private, city, or other public sites
- **Outreach and recruitment** to spur program participation
- Provide **benefit navigation, behavioral health referrals, job readiness assessments, individualized employment plans and meals** during work experience activities





## Program Outcomes

### Program Inception to December 2021

- 1,124 enrollments
- 765 participated at a work site
- 337 unique participants have achieved job placement outside of DDW, for a total of 587 times
- 65% of all placements last 90 days or more
- 39 participants placed in City positions
- 66 received support that led to housing
- 2022 target: 129 new job placements



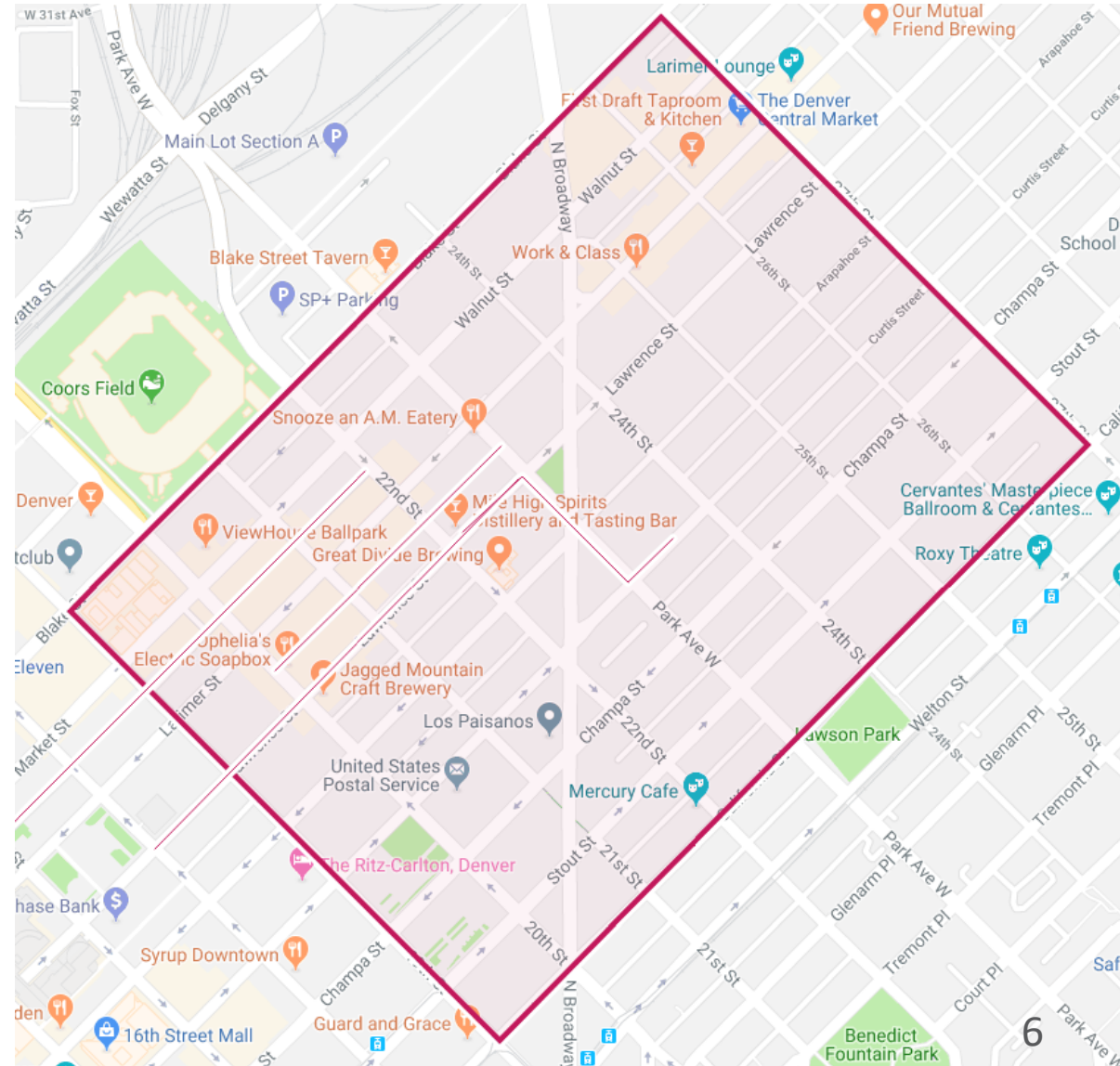
## Other Program Components

Denver Day Works Together: Street-level maintenance in Ballpark District, funded ~25% by Justice Assistance Grant in 2022

Five other contracts in/around Ballpark contribute funds and guidance to DDWT work crew

Combined Employment Services offerings with Back to Work funding (historically Bayaud Enterprises)

Four entry points: DDW @ Parks, DDWT @ Ballpark, Case Management, Career Center

## Scope of Work

- 220 households served
- 80% of households will increase or maintain income or non-cash benefits
- 80% of households who exit the program will obtain permanent or stable housing



## Client Offering

- 6-hour workday, once weekly for 10 weeks
- Support services delivered on-site to work experience
- \$100 cash at end of day
- Low-/no-barriers to participate

### Extension Worksites

- More work hours
- Closer connection to full-time jobs
- Higher skills development

Real Estate: 12 project sites cleaned by DDW work crews in 2021

Fleet Maintenance and Wastewater: Continuous service through 2021 despite COVID, 11 project sites cleaned
