1. Amend Ordinance Number 426, Series of 2007 and subsequent amendments thereto as identified above, to reallocate project funds within existing Better Denver Bond Program (Purpose 6 and Purpose 7) as further described below.
2. Purpose 6 Funding of streets, transportation, and public works system facilities
 - Peoria Street Grade Separation – reduce funding from \$2,500,000 to \$1,667,000
 - 38th and Blake Infrastructure – increase funding from \$4,023,000 to \$4,523,000
 - Broadway at I-25 and Mississippi – increase funding from \$4,800,000 to \$5,133,000
3. Purpose 7 Funding of Library System Facilities
 - Denver Public Library; New Branches for West Denver, Stapleton, and Green Valley – reduce funding from \$37,470,000 to \$33,588,493
 - Denver Public Library (various locations) – Increase funding from \$14,413,000 to \$18,294,507
