6 For an ordinance approving and accepting the park building plan for the
7 maintenance and operations facility, equipment building, and storage building,
8 all located in City of Cuernavaca Park, pursuant to the provisions of Sections 39-
9 210 and 39-211 of the Denver Revised Municipal Code.

11 **WHEREAS**, pursuant to the provisions of Sections 39-210 and 39-211 of the Denver Revised
12 Municipal Code (“DRMC”), the Department of Parks and Recreation submitted to City Council for
13 approval the building plan for a maintenance and operations facility, for an equipment building, and
14 for a storage building, all located in City of Cuernavaca Park; and

15 **WHEREAS**, the Department of Parks and Recreation and City Council now wishes to approve
16 the building plan for the buildings in City of Cuernavaca Park.

17 **NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF
18 DENVER;**

19 **Section 1.** After the Department of Parks and Recreation having provided the required notice
20 to the public and after submitting the building plan to City Council showing the required existing
21 structures, open space and additions, City Council now wishes to approve the building plan for the
22 maintenance and operations facility, equipment building, and storage building located in City of
23 Cuernavaca Park.
