6 **For an ordinance renaming Martin Luther King Boulevard as East Martin Luther**  
7 **King Jr. Boulevard from North Downing Street to North Syracuse Street.**

8 **WHEREAS**, this portion of land was previously dedicated as Martin Luther King Boulevard by  
9 Ordinance No. 48, Series of 1980 and recorded at Book 2114 Page 495, Reception Number  
10 1980066860, in the Office of the Clerk and Recorder, City and County of Denver;


11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

12 **Section 1.** The Council hereby approves the renaming of Martin Luther King Boulevard to  
13 East Martin Luther King Jr. Boulevard in the following location:

14 Martin Luther King Boulevard lying east of North Downing Street and west of North Syracuse  
15 Street, which is the entire right of way that was previously renamed in Ordinance No. 48, Series  
16 of 1980.

17 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known as  
18 East Martin Luther King Jr. Boulevard.
