**A RESOLUTION**

**Establishing and designating the North Wynkoop Entertainment District.**

**WHEREAS**, the Colorado General Assembly has authorized local licensing authorities the ability to issue common consumption area licenses in Entertainment Districts;

**WHEREAS**, the Denver City Council adopted an ordinance in 2019 creating a comprehensive pilot program for common consumption licensure within Entertainment Districts in Denver that began in 2021;

**WHEREAS**, the Denver pilot program was adopted to encourage place-making and vibrancy in Denver and those goals have not changed;

**WHEREAS**, the North Wynkoop Promotional Association applied with the Department of Licensing and Consumer Protection ("DLCP") for certification of their promotional association, licensure of a common consumption area, and establishment of an Entertainment District on August 4, 2025;

**WHEREAS**, the North Wynkoop Promotional Association established neighborhood support for the license to issue at a public hearing held on October 7, 2025 and a hearing officer recommended approval of the application on October 16, 2025;

**WHEREAS**, the Executive Director of DLCP adopted the recommendation and approved the application subject to completion of all required inspections and reviews on October 31, 2025;

**WHEREAS**, the applicant has demonstrated compliance with all application requirements and has completed all major inspection requirements;

**WHEREAS**, DLCP has received no evidence or testimony in opposition of the application and only received evidence of community support;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** There is hereby established and designated the North Wynkoop Entertainment District whose boundaries include all land, inclusive of rights-of-way, located at 4180 Wynkoop St. By establishing the North Wynkoop Entertainment District, the city authorizes the licensing of designated common consumption areas in which alcoholic beverages may be sold and consumed subject to the requirements of the Denver Revised Municipal Code and the Colorado Liquor Code.
