The Denver Police Department has been partnered with the Denver Children's Advocacy Center (DCAC) to provide forensic interviews of children who are victims of physical or sexual abuse. This method of interviewing is also used when children are witnesses to other violent crimes. Forensic interviews are designed to provide legally defensible and developmentally appropriate interviews by utilizing specialized interviewers. These interviews are designed to minimize suggestive or leading questions and ensure these victims are interviewed in a trauma informed manner. This better ensures the rights of all parties involved in these investigations are properly protected and maintain the public trust in law enforcement's commitment to conduct unbiased investigations.
