What are SRFs?

A Special Revenue Fund (SRF) is any fund which must be devoted to some *special* use in accordance with specific regulations and restrictions.

2 Types:

- 1. Grant SRFs
- 2. Non-grant SRFs

Total Number of Grant SRFs	133
Number of Grant SRFs that have been inactive for 4 years or more	54
Total Number of Non-Grant SRFs	234
Number of Non-Grant SRFs that have been inactive for 4 years or more	76



SRF Housekeeping

Housekeeping: Closing out unused grant and non-grant SRFs

Over the years, BMO has worked with City agencies and the Controller's Office on periodic clean-up efforts for antiquated grant and non-grant SRFs.

2011: Administrative Closure of grant SRFs Authorized

As a result of these periodic housekeeping efforts, Council approved an ordinance amendment in 2011 to Denver Revised Municipal Code 20-52(e) to authorize the administrative close-out of grant funds.

Non-Grant SRF Closures:

• BMO has not previously sought similar permission to close-out non-grant SRFs. Rather, we have continued to submit successive ordinance requests to resolve these accounting clean-ups.



Effects of BR15-0223:

Request to Allow the Department of Finance (DOF) to administratively close-out antiquated SRFs

DOF would need to coordinate with the agency and its expending authority to ensure the following:

- 1. There is no source of revenue for the fund;
- 2. The purpose of the fund has been fulfilled; and
- 3. The fund balance is zero.

No Change to Creation of SRFs and Transfers

BR15-0223 would not change Council approval of:

- Request to establish new SRFs, and
- any fund transfers from a non-grant SRF (or any fund).

BR15-0223 would not allow any fund sweeping.
