6 **For an ordinance relinquishing a portion of the easement reserved in Ordinance**
7 **No. 98, Series of 1948, recorded with the Denver Clerk & Recorder at Reception**
8 **No. 2004117961, located at 1635 West 13th Avenue.**

9 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
10 found and determined that the public use, convenience and necessity no longer requires a portion
11 of the easement in the area hereinafter described, and subject to approval by ordinance, has
12 relinquished the same;

13 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in relinquishing a
15 portion of the easement reserved in Ordinance No. 98, Series of 1948, recorded with the Denver
16 Clerk & Recorder at Reception No. 2004117961, in the following area:

17 **PARCEL DESCRIPTION ROW NO. 2018-RELINQ-0000004-001:**

18 A PARCEL OF LAND BEING A PORTION OF QUIVAS STREET, VACATED BY ORDINANCE 98,
19 SERIES OF 1948, RECORDED AT RECEPTION NO. 2004117961. LYING SOUTH OF THE
20 EXISTING REGIONAL TRANSPORTATION DISTRICT PROPERTY AS DESCRIBED AT
21 RECEPTION NUMBER 2011021623, AND LYING NORTH OF THAT STRIP OF LAND, ABUTTING
22 THE NORTH RIGHT-OF-WAY OF WEST 13TH AVENUE, SAID STRIP BEING 3 FEET IN WIDTH
23 PER RECEPTION NUMBER 2017135867 ALL LOCATED IN THE NORTHWEST QUARTER OF
24 SECTION 4, TOWNSHIP 4 SOUTH, RANGE 68 WEST OF THE 6TH P.M., CITY AND COUNTY OF
25 DENVER, STATE OF COLORADO.



26 SAID PARCEL CONTAINS 15,372 SQUARE FEET, OR 0.3528 ACRES.

31 AND ON THE EAST BY A #6 REBAR WITH A 2.5" ALUMINUM CAP IN RANGE BOX LS#38320
