A RESOLUTION

Accepting and approving the plat of Boulevard One Filing No. 5.

WHEREAS, the property owner of the following described land, territory or real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

Lot 1, Lot 2, Tract H and Tract W, Block 6, Boulevard One Filing No. 1, recorded at Reception Number 2014105351 in the Clerk and Recorder’s Office of the City and County of Denver, located in a part of the Southeast Quarter of Section 8, Township 4 South, Range 67 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado,

Containing 228,305 square feet or 5.241 acres, more or less.

propose to lay out, plat and subdivide said land, territory or real property into a block, lots and tracts, and have submitted to the Council of the City and County of Denver a plat of such proposed subdivision under the name and style aforesaid, showing the adjacent streets and platted territory, accompanied by a certificate of title from the attorney for the City and County of Denver; and dedicating public utilities and cable television easements as shown thereon;

WHEREAS, said subdivision was surveyed by or under the direction of the City Engineer of the City and County of Denver and said City Engineer has certified as to the accuracy of said survey and said plat or map and their conformity with the requirements of Chapter 49, Article III of the Revised Municipal Code of the City and County of Denver, and said plat has been approved by the City Engineer, the Executive Director of Community Planning and Development, the Executive Director of Public Works and the Executive Director of Parks and Recreation;

BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the Council hereby finds and determines that said land, territory, or real property has been platted in strict conformity with the requirements of the Charter of the City and County of Denver.

Section 2. That the said plat or map of Boulevard One Filing No. 5 and dedicating to the City and County of Denver dedicating public utilities and cable television easements, as shown thereon, be and the same are hereby accepted by the Council of the City and County of Denver.
