A BILL

For an ordinance making a rescission from and appropriation in the City Council General Fund to make a cash transfer to and appropriations in the City Council Special Revenue Fund.

10 **WHEREAS**, the City Council may procure professional services for work within the scope of
11 its duties and obligations under the Charter and Ordinances of the City and County of Denver; and

12 **WHEREAS** the City Council Central District Operations wishes to transfer 2025 savings to
13 the City Council Special Revenue Fund to support the procurement of professional services in
14 2026;

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
