SELECTION PROCESS

- DEN published a Request For Proposal on August 18, 2017
 - A mandatory pre-proposal conference was held at DEN on August 30, 2017
 - Proposals were due on October 2, 2017, and two (2) proposals were received
 - Interviews were conducted on November 3, 2017

SELECTION PROCESS



- Selection criteria focused on two (2) categories
 - Narrative which focused on the following nine (9) groups:
 - Cover letter
 - Respondent's core business
 - Respondent's experience in the marketplace
 - Respondent's general technological superiority
 - Respondent's product/support quality superiority
 - Respondent's products and service offerings
 - Respondent's certifications and/or accreditations
 - Respondent's independent reviews
 - Additional information
 - Cost proposal



GOALS

- The Division of Small Business Opportunity (DSBO) has determined that this contract's Scope of Services does not fall under provisions of Denver's Construction or Purchasing Ordinance



CONTRACT TERMS AND AMOUNT

- Both contract terms are three (3) years, with an option to extend for two (2) additional years
- JW Group Contract value: \$5,000,000.00
- AECOM Contract Value: \$10,000,000.00
