6 **For an ordinance approving the purchase of capital equipment from the**
7 **Wastewater Management Division Planned Fleet Replacement Fund.**

9 **WHEREAS**, the Department of Transportation and Infrastructure has reassessed current
10 department needs and determined that it requires a flatbed truck with a water tank/vac/tool rack/jet
11 to perform green infrastructure maintenance responsibilities in lieu of three other vehicles
12 authorized in the 2020 Budget (Reference #'s 20-743, 20-195, and 20-744);

14 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**

17 **Section 1.** From the Wastewater Division Planned Fleet Replacement Fund, Accounting No.
18 72200-5060000, the Executive Director of the Department of Transportation and Infrastructure, or
19 his duly authorized representatives, is hereby authorized to purchase or acquire the following capital
