This amendment will provide partial funding for the flood mitigation project and infrastructure improvements of a drainageway defined as Sanderson Gulch Reach 1, beginning at S. Lipan Street and extending southeast to the confluence of the South Platte River. The funds will be received from DHSEM as a pass through entity for the Federal Emergency Management Agency (FEMA).

This agreement along with an 201733801 (HUD) and amendment 201523631 UDFCD are all related to the Sanderson Gulch project and require resolutions and budget ordinances. They should be processed together.
