A BILL

For an ordinance making a rescission from and an appropriation in the Parks Legacy Capital Fund.

WHEREAS, Ordinance No. 0083, Series of 2019, appropriated budget in the Parks Legacy Improvement Projects Fund for a Parks Resiliency Plan; and

WHEREAS, COVID-19 forced Resiliency Master Plan projects to be placed on hold; and

WHEREAS, the Department of Parks and Recreation (DPR) has worked closely with the CSU Salazar Center and the Office of Climate Action, Sustainability and Resiliency (CASR) to evaluate a scope for a citywide Resiliency Master Plan; and

WHEREAS, the City desires to use funds from the Parks Legacy Improvement Projects Fund to support implementation of climate action, mitigation, and adaptation projects that have been prioritized to move forward;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the Parks Legacy Capital Fund, Accounting No. 36000, there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":

5 The foregoing appropriation is to support resiliency projects including updating parks landscape
6 typology data for projects that reduce potable water use for irrigation, restore native habitat,
7 increase water conservation, and improve the health of lakes and waterways; the shoreline
8 conversion project at Garland Park; the preservation of the cormorant rookery at Duck Lake; and
9 lake aeration at Overland Park to prevent fish kills and algae blooms.

12 and directed to make such book and record entries and to do such other things as may be necessary
13 to accomplish the purposes of this Ordinance.
