A BILL

For an ordinance to change the name of the “Summer Youth Employment” Special Revenue Fund to the “Youth Employment and Training Programs” Special Revenue Fund and to clarify allowable expenditures.

WHEREAS, the Summer Youth Employment Special Revenue Fund, Fund number 17603 was created through Ordinance No. 199, Series of 2007, when the Summer Youth Program moved to the Office of Economic Development (currently Denver Economic Development and Opportunity, DEDO) and not by an ordinance that explicitly defined its parameters; and

WHEREAS, since then, this SRF has been used to administer primarily summer youth programs; and

WHEREAS, DEDO recently received an award from CareerWise and has begun implementing the CareerWise Youth Apprenticeship program, a three-year program that engages with high school and college students and connects them to hands-on training, networking, and professional development within city government; and

WHEREAS, while the program was entirely grant-funded in 2021, starting in 2022, the program will also be funded by a General Fund transfer to Fund 17603; and

WHEREAS, the City therefore desires to clarify the use of Fund Number 17603 and change the name from the “Summer Youth Program” to the “Youth Employment and Training Programs” to reflect the Fund’s expanded scope to include other youth employment and training programs;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The “Summer Youth Employment” Fund, Accounting No. 17603, in the Economic Opportunity Special Revenue Fund Series, is hereby named the “Youth Employment and Training Programs” Fund.

1 **Section 2.** Monies received from transfers from other City funds, program income, donations,
2 and other sources of revenue for Accounting No. 17603 shall be deposited into the Treasury of the
3 City and credited to Special Revenue Fund No. 17000, which is set forth and described in Section
4 20-18 of the Revised Municipal Code of the City and County of Denver.

5 **Section 3.** Allowable expenditures for the “Youth Employment and Training Programs” Fund,
6 Accounting No. 17603 to be expended by the Executive Director of the Denver Economic
7 Development and Opportunity, include youth employment programs as well as training programs.
8 This Fund is appropriated and non-lapsing.

9 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
10 and directed to make such book and record entries and to do such other things as may be necessary
11 to accomplish the purposes of this Ordinance.
