- The proposed eighth amendment would:
 - Extend the term of the contract by six months to 06/30/2016; and
 - Appropriate an additional \$81,000.00 bringing the total contract amount to \$1,266,272.00; and,
 - Lower the bonding requirements by one-half; to be One Hundred Thirty Seven Thousand Six Hundred Dollars and no/100 (\$137,600.00). This Contractor Responsibility is a change that was agreed upon between the City of Denver City Attorney's office and the Vendor during the execution of contract Amendment Seven; however it was an administrative oversight not to include this modification in the contract language at that time.
- A formal Request-for-Proposal (RFP) is in process to identify a single enterprise-wide vendor to provide an upgrade to the equipment of the current Photo Red and Photo Speed programs and to maintain those programs for a period of no less than five years. Reference Bid RFP-KJ-7250
