- BR11- 0423 Amends the contract with Qwest Communications for broadband service data at Denver International Airport to add \$160,000 to the current contract and to increase the overall service offering and to extend the term through May 22, 2012 (CE65011).
- BR11- 0441 Amends the on-call contract with Pinkard Construction to extend the term from August 1, 2011 through August 1, 2013 for various construction projects at Denver International Airport (CE 03053-01).
- BR11- 0442 Amends the on-call contract with Milender White Construction Company to extend the term from August 1, 2011 through August 1, 2013 for various construction projects at Denver International Airport (CE 03018-01).

- BR11- Amends the on-call contract with Roadsafet Traffic Systems for

\$1,000,000 for a new total of \$1,794,250.
- BR11- Approves a \$1,418,855 contract with ABCO Contracting for the project
