A BILL

For an ordinance approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the U.S. Department of Energy concerning the “Energy Efficiency and Conservation Block Grant Program (EECBG)” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the City and County of Denver and the U.S. Department of Energy for the “Energy Efficiency and Conservation Block Grant Program (EECBG)” Grant, which is identified as Grant Number DE-SE0000445, a copy of which is duly filed with the City Clerk, Filing No. 202473155, be and hereby is approved in all respects.

Section 2. The payments made by the U.S. Department of Energy to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Capital Grant and Other Money Projects Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Office of Climate Action, Sustainability, and Resiliency is as follows:
