There is hereby established in the Public Safety Special Revenue Fund, 15 Accounting No. 12000, a "Police/Fire Pension" fund, Accounting No. 12824-3500000, for the 16 purpose of receiving and expending funds related to Police/Fire Pensions in accordance with 17 statute, for current and future contributions. 18 **Section 2.** Monies received from Police and Fire Pension mills and the employer contribution 19 for new hire police and fire pension contributions and other sources of receipts shall be deposited 20 into the Treasury of the City and credited to Special Fund No. 12000, which is set forth and 21 described in Section 20-18 of the Revised Municipal Code of the City and County of Denver. 22 **Section 3.** Expenditures are hereby authorized for the "Police/Fire Pension" fund, Accounting 23 No. 12824-3500000, in the amount not to exceed the total of deposits described in Section 2 of 24 this Ordinance, to be expended by the Executive Director of Safety. Authorized expenditures will 25 include, but shall not be limited to annual payments for Police and Fire pensions.
