A RESOLUTION

Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the High Line Canal Conservancy for the “High Line Canal Conservancy Enhanced Trail Surface and Green Valley Ranch Canal Improvement Zone” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the City and County of Denver and the High Line Canal Conservancy, for the “High Line Canal Conservancy Enhanced Trail Surface and Green Valley Ranch Canal Improvement Zone (CIZ)” program, which is identified as City Grant Contract Number 202477052, a copy of which is duly filed with the City Clerk, Filing No. 202477052, be and hereby is approved in all respects.

Section 2. The payments made by the High Line Canal Conservancy to the City pursuant to and under the amended Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 15000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of Parks and Recreation, is as follows:
