A. City Attorney - Sara King

BR10-0429 - Amend the contract with West Publishing Corporation, d/b/a Thomson West, CE85004, to revise the online legal research access schedule and the print material discount schedule and increase the contract cap amount by \$50,000 for a total of \$700,000 for the five-year term.

B. Community Planning and Development - Jeremy Wells/Ellen Ittelson

BR10-0432 - Amends the Downtown Historic District Tax rebate ordinance to require a single representative of any condominium buildings; specify that rebates less than \$100 will not be distributed; and modify annual certification dates to reflect actual practice.

BR10-0433 - Amend the Commons PUD to extend the vesting period.

CB10-0438 - A bill for an ordinance approving a proposed Second Amendment to Agreement between the City and County of Denver and RMES Communications, Inc. concerning internet kiosk services at Denver International Airport.
