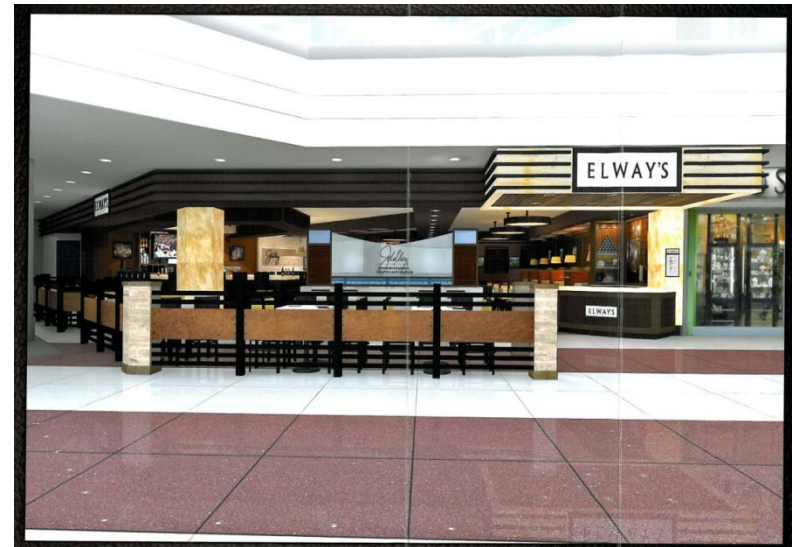

# Aggregate Economic Benefits

- \$14.6M in overall additional annual revenues
- \$1.6M in additional annual rents to DIA
- \$434K in additional annual sales tax to CCD
- 120 permanent and temporary jobs employees
  - New locations account for roughly 50 of these jobs, due to change in business use at some locations

# Airport Concessions Disadvantaged Business Enterprise (ACDBE) program

- ACDBE goals are set by the OED Division of Small Business Opportunity (DSBO)
- Approximately \$7.9M ACDBE revenues
- ACDBE revenues account for 55% of projected total
