2	The building sewer line serving the existing building to be demolished or moved must be properly cut-off, and then inspected by PW WMD, prior to issuance of a Sewer Use & Drainage Permit for any new building(s). If the cutoff location cannot be made as required by PW WMD, the licensed plumbing or sewer contractor shall coordinate with PW WMD Plumbing Inspection to have the inspection pre-cleared. ELC 11/13/2009 The PW WMD Plumbing Inspector must also verify if the existing structure(s) to be demolished are on a septic system or connected to storm, if no building sewer connection is tied to the sanitary sewer system. Also, all domestic water tap sizes that service the existing buildings to be demolished must be verified and documented by the PW WMD Plumbing Inspector as part of the cutoff inspection.
