I write to speak in favor of the zoning change to support the development of a soccer stadium in Baker. The site selected represents a rare opportunity to confront real challenges of Denver history and start a new chapter. From Gates Rubber, to I-25, to Burnham Yards, the central rail corridor of Denver has long been a site of private infrastructure that has supported local employment and development while, unfortunately, often creating multi-generational public harms in the form of pollution, contamination, and blight. It has been a valuable north-south transit corridor, while simultaneously blocking East-West travel and functional integration. With the proposed stadium, Denver has a chance to preserve the legacy of private enterprise supporting broad economic development in this central corridor. More so, we have the opportunity to do so in a way that potentially encourages the repurposing of long contaminated land, and refocuses the I-25/Broadway/Santa Fe junction area as a central transit junction point, spreading the benefits of development far beyond the immediate site in a way that is accessible to many forms of transit.

I recognize the profound concerns that come with public support of private sports enterprise. In many cities, the benefits have been marginal. Yet, with the proposed structure, Denver retains

an interest for its investment in one of the most crucial undeveloped central land tracts of the city. Unlike in other places, where stadium sites have been on the far fringes that require scratch development of supporting infrastructure, the proposed site here is centered around existing transit infrastructure, with access to current historic commercial districts in Overland, Broadway, and Baker. These areas have struggled mightily since COVID, with consistent business turnover, constant construction on Broadway, and variable RTD schedules and access. With this stadium proposal, Denver doesn't simply privilege the moneyed interests who can support scratch development. We also support the stability and sustainability of existing, long-time business and communities near the site.

For Denver to move beyond its many current crises, we can't just shave down services, support, and vision bit by bit - withering while we wait for recovery. We must support and invest in a vision that moves us towards a more sustainable future. With this stadium, Denver has a rare opportunity to exercise a real vision, and I encourage us to take it.
