**A bill for an ordinance creating a Fund Number in the Human Services Special Revenue Fund for the “Affordability Program”.**

**WHEREAS**, the Department of Human Services requests a new fund number for the Affordability Program;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** A new Fund is hereby established in the Human Services Special Revenue Fund, Accounting No. 13000, an “Affordability Program” fund, Accounting No. 13813 for the purpose of accounting for the receipt and expenditure of program dollars.

**Section 2.** Monies received from fund transfers or other sources shall be deposited into the Treasury of the City and credited to Special Fund No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** Project expenditures are hereby authorized for the “Affordability Program” fund, Accounting No. 13813, as appropriated in Denver’s Annual Appropriating Ordinance and other ordinances making appropriations or rescissions for said fund for the purposes described in section 1 of this Ordinance. This is a lapsing fund.

1       **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
2 and directed to make such book and record entries and to do such other things as may be  
3 necessary to accomplish the purposes of this Ordinance.
