A BILL

For an ordinance making a supplemental appropriation from the General Contingency Fund to purchase property at 700 West Colfax Avenue.

WHEREAS, Council Bill No. 590, Series of 2018, has been submitted to the City Council to request a purchase and sale agreement to acquire property located at 700 West Colfax and 1449 Galapago Street for office support for the district and county courts in Council District 10;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
