5 **To set a public hearing on the approval of Service Plans for the proposed**
6 **South Sloan’s Lake Metropolitan District No. 1 and South Sloan’s Lake**

9 **WHEREAS**, proponents have submitted service plans for the creation of two metropolitan
10 districts for the St. Anthony’s Central Campus redevelopment project, which project is generally
11 located South of 17th Avenue, North of Colfax Avenue, West of Perry Street and East of Stuart
12 Street; and

13 **WHEREAS**, City Council desires to set a public hearing on such service plans;

15 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

17 **Section 1.** Date, Time, and Location of Public Hearing for Metropolitan Districts. The City
18 Council shall conduct a public hearing on the Service Plan for South Sloan’s Lake Metropolitan
19 District No. 1 and the Service Plan for South Sloan’s Lake Metropolitan District No. 2. The public
20 hearing shall be on Monday, August 5, 2013, at 5:30 p.m. in Council Chambers in the City and
21 County Building located at 1437 Bannock Street, in Denver, Colorado.

22 **Section 2.** Other Notices. The proponents of the districts shall give any statutorily
23 required notices.

24 **Section 3.** That the Clerk of the City and County of Denver shall attest and affix the seal
25 of the City and County of Denver to this Resolution.
