Measles 2025 - National Context

- In 2024, **285 measles cases** total measles cases reported nationwide
- 1,319 confirmed cases of measles reported in 2025 (as of 7/22/25)
- 87% of cases are associated with outbreaks.

Notable State Outbreaks:

- Texas/New Mexico (January 2025 to present)
 - 762 cases in West Texas, 95 cases in New Mexico
 - 93% cases unvaccinated or unknown vaccination status
 - Outbreak is active but slowing. Most recent case reported from early July.
- Kansas (March 2025 to present)
 - 87 cases in southwest Kansas.
 - 92% unvaccinated/unknown/not age appropriately vaccinated.
 - Most recent case reported in early July.

International Outbreaks:

- Canada (October 2024 to present)
 - 2,248 cases reported across Canada. Majority reported in Ontario.
 - Outbreak appears to be slowing but continuing to report cases across the country.
- Mexico (2025)
 - 2,597 cases reported. Majority reported throughout Chihuahua.
 - Continuing to see an increase in cases.



Measles 2025 - Local Context

- Between 2017 and 2024, there were just 4 cases reported in CO
 - All international travel-associated
- 16 cases of measles reported in CO residents in 2025 (as of 7/22/25)
- Additional out-of-state measles cases who were residing, traveling, or seeking medical care in CO while infectious.

Traveler Associated Outbreak

- 10 of the 16 CO cases were associated with an out-of-state case who traveled while infectious
 - 4 from the same international flight
 - 5 exposed at DEN
 - 1 secondary case from an exposed traveler

Denver Cases

- 4 confirmed cases in Denver County residents
 - 1 exposed to the ill traveler on the international flight
 - 2 travelled to outbreak area in Mexico
 - 1 secondary case in a household contact



DDPHE Response Strategy: Case Investigation





Confirm symptoms

Establish timeline of disease

- Conducted by Disease Intervention and Epidemiology staff
- In-depth case interviews
- All suspected and confirmed cases who reside in Denver County







DDPHE Response Highlights

- Contacted and assessed approx. 437 individuals, 186 identified as high-risk contacts
- Referred or administered post-exposure prophylaxis to 28 high-risk contacts
- No known secondary cases from any healthcare exposure
- DDPHE nurses deployed to provide home testing for several suspected cases
- Recently conducted an in-depth walkthrough of the Denver Health Emergency Department, and an in-depth review of their air handling system



Back to School Vaccination

Required vaccinations for school-aged children

- 5 vaccines are required for Kindergarten entry
- HepB, DTap, IPV, MMR, Varicella

Exemption rates

- CO avg 7.9% (NME)
- Denver avg 3-4%

Vaccination rates for Denver:

84.3% - 84,273 students
