Description: Public Hearing on Landmark Designation of Structure Chair Holdorf opened the public hearing Staff report by Kara Hahn, Senior City Planner Presentation by Applicants, Daniel Findley, 2924 Zenobia St., and Paul Cloyd, 3033 Yates St., Summary:

- All of the applicants listed on the application is indicative of the community effort behind the application.
- History Criteria The house meets this criteria because it was built and inhabited by the Lambourns', who made their living as florists at a time when there was a floral district in Denver.
- Architecture Criteria This home is an example of an early adapted Denver Four Square design. The home was designed by the architect Richard Phillips.
- Geography Criteria the house sits on a hill and overlooks northwest Denver. Locals have called it 'the white manor', 'watching house', 'the castle', and 'the house on the hill'. It is an icon.

Presentation by David Foster, 360 S. Garfield St., representing Owner – Brad Teets, 5310 DTC Parkway, Greenwood Village, CO.

Summary:

- Despite all of the community outreach, petitions and comments only one person from the group in favor of designation contacted the owner. Had the applicant filed for designation sooner and reached out to the owner a continuance or compromise may have been sought.
- Criteria Although the staff recommends designation based on the property meeting criteria the report states that the property only 'strongly' meets one criteria. The other it merely 'meets' the criteria. The Commission is not compelled to designate based on the structure meeting criteria. It may designate but it is not required to designate.
- Architecture Criteria The staff report shows that this is a "good example" of a Denver square by an architect that was prolific but not recognized. The owner would like a continuance of the case so that the professional opinion of an architect may be sought.

Owner, Brad Teets, presented

- The neighborhood didn't make an effort to discuss the designation with me.
- This is not a historic neighborhood
- I have missed economic opportunities due to the structure being involved in the designation process.
- The Commission is not compelled to designate based on the structure meeting criteria. It may
 designate but it is not required to designate.
