This request is to amend the contract maximum from \$400,000.00 to \$3,400,000 for the continuation of security personnel services at unhoused and newcomer sites citywide, excluding Denver International Airport.

The original contract was executed to fill a gap due to the influx of security requests for security personnel services for unhoused and newcomer shelter sites citywide during the second half of 2023. These new additional requests included 24/7 coverage at facilities, vehicle patrols at micro-community sites while under construction, and the need for quick response times to spin up new sites within a 24-hour notice. During this time, Securitas Security Services USA, Inc., the current security personnel service provider contracted with the city was unable to keep up and meet the rapidly changes needs of the city.
