**A BILL**

**For an ordinance making an appropriation in and a rescission from General Fund Contingency and making an appropriation in the General Fund budget for the City Attorney’s Office.**

**WHEREAS**, the City Attorney’s Office (CAO) has entered a partnership with the U.S. Attorney’s Office (USAO) to address violent crime in Denver; and

**WHEREAS**, as part of the said partnership, four Associate Assistant City Attorneys will serve as Special Assistant United States Attorneys (SAUSA) and work with and under supervision of USAO to deal specifically with the surge of gun crime in Denver and to prosecute cases involving felons in possession of a firearm under 18 USC § 922; and

**WHEREAS**, the City wishes to increase the CAO 2022 General Fund appropriation;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
