4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as a public alley bounded by Cherokee Street, Bannock Street, West 3rd**
7 **Avenue and West 4th Avenue.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public alley designated as part of the system of thoroughfares of the
11 municipality those portions of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public alley;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

18 **PARCEL DESCRIPTION ROW NO. 2016-DEDICATION-0000163-001:**

19 A parcel of land conveyed to the City of Denver by Warranty Deed, recorded on the 17th of
20 December 1887, in Book 355, Page 370, in the Clerk & Recorder’s Office, City & County of
21 Denver, said parcel of land being located in the Northwest 1/4 of Section 10, Township 4 South,
22 Range 68 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado, and
23 being more particularly described as follows:

25 South fifteen feet of Lot numbered three in Block numbered nine (9), Broadway Terrace Addition to
26 Denver. To be used as an alley by the public generally.

27 be and the same is hereby approved and said real property is hereby laid out and established and
28 declared laid out, opened and established as a public alley.

29 **Section 2.** That the real property described in Section 1 hereof shall henceforth be a public
30 alley.
