5 **Approving and providing for the execution of a proposed Grant Agreement**  
6 **between the City and County of Denver and the Colorado Department of**  
7 **Transportation concerning the “16<sup>th</sup> Street Mall Reconstruction” program and**  
8 **the funding therefor.**

10 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
11 Grant Agreement;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**  
14 **OF DENVER:**

16 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the  
17 Colorado Department of Transportation, for the “16<sup>th</sup> Street Mall Reconstruction” program, which is  
18 identified as Grant Number 21-HA1-XC-03151, a copy of which is duly filed with the City Clerk, Filing  
19 Nos. 202056868 and 202158042, be and hereby is approved in all respects.

20 **Section 2.** The payments made by the Colorado Department of Transportation to the City  
21 pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and  
22 credited to Special Revenue Fund No. 38000, which is set forth and described in Section 20-18 of  
23 the Revised Municipal Code of the City and County of Denver.

24 **Section 3.** That it be and is hereby found and determined that the budget summary of said  
25 program, to be expended by the Executive Director of the Department of Transportation and  
26 Infrastructure, is as follows:
