**A BILL**

**For an ordinance changing the zoning classification for 2001 South Acoma in Overland.**

9 **WHEREAS**, the City Council has determined, based on evidence and testimony presented at  
10 the public hearing, that the map amendment set forth below conforms with applicable City laws, is  
11 consistent with the City’s adopted plans, is in the public interest, and is consistent with the  
12 neighborhood context and the stated purpose and intent of the proposed zone district;

13 **NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
14 **DENVER:**

15 **Section 1.** That upon consideration of a change in the zoning classification of the land area  
16 hereinafter described, Council finds:

- 17 a. The land area hereinafter described is presently classified as U-RH-2.5.
- 18 b. It is proposed that the land area hereinafter described be changed to C-RX-5.

19 **Section 2.** That the zoning classification of the land area in the City and County of Denver  
20 described as follows shall be and hereby is changed from U-RH-2.5 to C-RX-5:

21  
22 LOTS 47 & 48, BLOCK 7, ROSEDALE, LYING IN THE NORTHWEST QUARTER OF  
23 SECTION 27, TOWNSHIP 4 SOUTH, RANGE 68 WEST OF THE 6TH PRINCIPAL  
24 MERIDIAN, CITY AND COUNTY OF DENVER, STATE OF COLORADO.

25  
26 CONTAINING 6,250 SQUARE FEET OR 0.1435 ACRES, MORE OR LESS.

27  
28 in addition thereto, those portions of all abutting public rights-of-way, but only to the centerline  
29 thereof, which are immediately adjacent to the aforesaid specifically described area.

30 **Section 3.** That this ordinance shall be recorded by the Manager of Community Planning and  
31 Development in the real property records of the Denver County Clerk and Recorder.
