Greetings,

I am writing to respectfully ask that you do not approve the South Sloan's Lake General Development Plan without mandating some key changes.

While I support revitalization, I strongly oppose the current GDP, which includes 20 and 12-story buildings at Sloan's Lake.

The vast majority of speakers at the Planning Board hearing on 12.18.13 expressed serious concern about the excessive scale of this plan, and its lack of open space. Ignoring taxpayers' and citizens' concerns is incompatible with good governance and is not what I as a voter wish to see in Denver.

I respectfully ask that you, and the Development Review Committee, only approve a GDP for South Sloan's Lake once it has been amended to reflect the following:

- -Increased open space from 1.4 to 2.5 acres, to be aggregated along 17th Avenue
- -Building heights not to exceed 3 stories on the site's perimeter
- Building heights in the interior not to exceed 8 stories

These changes reflect citizens' input, require a modest increase in zoning and are consistent with the extensive St. Anthony's Redevelopment Task Force Plan.

In addition, the West Highland Neighborhood Association has requested Councilwoman Shepherd to initiate rezoning of this property immediately, to reflect the above points. I support this and respectfully request that you do the same.

Right-sizing the GDP and proactively changing zoning now avoids multiple divisive and costly zoning fights over this site in the future; it provides the predictability that both residents and developers deserve and will be an example of great leadership by the Mayor and City Council.

Dear Members of Denver City Council:

We are writing to you today in regard to the Rezoning Application from EnviroFinance Group, a Delaware Corporation dba EFG – South Sloan's Lake, LLC, in re: 1606 Stuart Street. The Applicant is requesting a rezoning from C-MX-5/DO5 to C-MX-12/DO5.

You may be under the impression that there is little or no opposition to this application. Please be advised that the opposition to this particular rezoning and the General Development Plan (GDP) approved by the Design Review Committee of the Community Planning and Development (CPD) has been ongoing for more than 3 years and runs deep throughout West and Northwest Denver.

Opposition stems from two basic facts. First and foremost, the developer, through its officers and agents have, from the beginning of their outreach in late 2011, consistently ignored requests to follow the key recommendations and "Guiding Principles" of the St. Anthony Redevelopment Task Force which were made part of the West Colfax Plan, the legally binding small area plan. These Guiding Principles directly stipulate building massing and location, open space concepts and connectivity to the neighborhood.

Most important of those principles was that the tallest buildings in the development were to be massed in the center and towards West Colfax thus casting the smallest shadow patterns and affording the best views of the mountains, Sloan' Lake Park and downtown. In addition, the concern strongly expressed by the community during the Task Force process, with few exceptions, was based on not setting a precedent for future high rise development around the Lake This was not just one guiding principle, this was the absolute key guiding principle of the small area plan.

Secondly, while Community Planning and Development and the applicant consistently assured residents that the planning concepts incorporated into the General Development Plan did not constitute zoning, the GDP process moved a development forward with density, open space, street capacities and building heights set without the benefit of Council oversight. At the Planning Board public hearing there were at least 4 times as many testifying against the plan with more than 100 people in opposition in attendance. An online petition gathered more than 700 signatures primarily from resident from throughout NW

The GDP contains very specific plans regarding building height and location outside the bounds of what is intended to be a technical document. That the rezoning request follows the GDP comes as no surprise. However, the GDP is not an adopted plan and there are no rights vested in this document. Council must consider the current rezoning proposal only in light of the West Colfax Plan and any conditions which have changed since 2010. Although there can be no dispute that some of the Guiding Principles of the West Colfax Plan have been met, the massing and location of buildings is paramount and cannot be overlooked. Return on Investment from "lakeside" development is not a legitimate condition for which zoning changes can be made.

During the GDP process and the more recent rezoning process for this parcel, the developer, EFG, has maintained that the language, that the tallest buildings were to be in the center of and back toward West Colfax, as only advisory and not binding. City Attorney, Lori Strand, however, at the Planning Board hearing on December 3, 2014, confirmed to the Board that the Guiding Principles of the St. Anthony Task Force Report are, based on clear and specific language, part of the adopted by ordinance, West Colfax Plan.

Despite repeated representations to the contrary by EFG, the truth is opposition to the proposed development runs deep and furious in the immediate area. Attached are petitions in opposition to this rezoning with approximately 500 signatures from residents who live closest to the east, south and west of the development site. Signatures are still be gathered and may presented at the hearing. In addition, nearly 80% of the Westside Jewish Community who live closest to the development site signed petitions in opposition to this rezoning. The signatures presented here are from what has become known as "Ground Zero" and such opposition should not be ignored.
