State law requires a public hearing be conducted prior to City Council approving a Service Plan for a new metropolitan district, or an amendment to a service plan for an existing district, with no less than 20 days' notice before the hearing. The public hearing for the West Globeville Metropolitan District No. 1 and West Globeville Metropolitan District No. 2 is anticipated to be September 30, 2024.

This legislative item is the first of two items related to the first amendment to the First Amended and Restated Service Plans of West Globeville Metropolitan District Nos. 1 & 2. This resolution will reserve a public hearing date for consideration of the Districts' respective amended service plans on September 30, 2024. The second legislative item will be an ordinance seeking approval of the respective amendments to the service plans. The ordinance request will be submitted on August 30, 2024.
