6. General description of proposed ordinance including contract scope of work if applicable:

This ordinance will approve a contract amendment for the Denver Arts & Venues Promoter Commission Program to induce the Promoter to host events in City venues. The venues in question are in Council District 8 (Denver Coliseum and Red Rocks Amphitheatre). The contract amendment establishes a commission program to incentivize Promoter to promote and book live concerts and events at the Denver Arts & Venues facilities. The purpose of this commission program is to increase revenues to the City in the form of ticket sales and concessions. This program is essentially the same as the program used in calendar years 2014-2016 and the amendment will cover the 2017 event season.
