21	deleting the language stricken and adding the language underlined to read as follows:
22	"(b) This article V shall be repealed effective April 30, 2025 October 31, 2026."
23	Section 3. Section 28-236(b) of the Denver Revised Municipal Code is amended by
24	deleting the language stricken and adding the language underlined to read as follows:
25	"(b) This article VII shall be repealed effective April 30, 2025 October 31, 2026."
