9 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

10 **Section 1.** That subsection 14-109 (a), D.R.M.C. shall be amended by deleting the language
11 stricken and adding the language underlined, to read as follows:
12

13 **Sec. 14-109. Salary and benefits of county court magistrates.**

14 (a) Each full time county court magistrate shall be paid a salary equal to a compa-ratio
15 of ~~1.076~~ 0.972 of the pay grade ~~818-L~~ applicable to the job classification entitled
16 “Assistant City Attorney—Senior” in the legal occupational group in the then current
17 classification and pay plan adopted and maintained in accordance with chapter 18,
18 division 2 of article II.
19

20 (b) Each part time county court magistrate shall be paid an hourly rate equal to a
21 compa-ratio of ~~0.924~~ 0.832 of the pay grade ~~818-L~~ applicable to the job classification
22 entitled “Assistant City Attorney—Senior” in the legal occupational group in the
23 classification and pay plan adopted and maintained in accordance with chapter 18,
24 division 2 of article II.

26 **Section 2.** This ordinance shall be effective January 1, 2014.
