RE: Alley Vacation Request, World Trade Center, southerly dead-end portion of NE-SW Alley parallel to and between Blake & Walnut Streets

Dear Sir/Madam:

I represent the owners and developers of the World Trade Center project, which in turn owns most of the southwestern half of the block bounded by 38th, 40th, Blake, and Walnut Streets. The ownership entities consist of Carbat, LLC, and 3853 Walnut, LLC, DBA as Formativ, with both headed by Sean Campbell.

This requested vacation is intended to facilitate development of the World Trade Center project (2016-PM-0000745). The area currently consisting of a 100' long by 16' wide dead-end alley is intended to serve as a loading dock for the World Trade Center project. No other owner on the block will be affected by the proposed vacation, as this portion of the alley is dead-end portion of an alley T-intersection. The alley portion to be vacated is surrounded by Formativ's holdings and the remaining "T" portion of the NE-SW alley.

This request to vacate the alley is being sought with a long-term plan to manage access and use of this vacated portion of the alley under license agreements with utility providers, as well as existing and future abutting owners. The idea is to enable use as a private loading dock serving the entire hotel, office, and retail project, and accommodate all utilities and hard surface easement requirements. There are no plans to explore options to use the alley other than as a loading dock.

The alley is a dead end because the remaining southwesterly portion was vacated in 1964, most likely because it could not physically connect to the 38th St. underpass. A 50'X16" sanitary easement in place in lieu of that 1964 vacation exists just to the southwest and as an extension of the dead-end alley ROW land. It is expected to be relinquished as the sanitary line currently serving the adjacent, existing buildings through the alley will be completed relocated out of the former alley. As noted below, a replacement line will serve the new project but will connect directly to existing Blake or Walnut lines.

The area of the alley leading northeast from the T-intersection (and the dead-end, vacated portion) will remain and be widened from 16' to 20', inclusive of a 2'-wide land dedication by Formativ. (After the vacation the alley it will "L" to the northeast to 40th St. and north to Blake St.)

Besides the current limited use of the dead-end alley for deliveries, the following is a list of the current utilities in the alley, with notations regarding intent to relocate or remain:

- Sanitary sewer facilities to be relocated and rights to services are anticipated to be relinquished as part of this vacation. Sewer service to the block and project will be provided from Blake and/or Walnut; and,
- Electrical and fiber, to be undergrounded or relocated, via license/easement agreement. We have been working with Kate Middleton of Xcel, and Kip West with Comcast, and Mo Click of Centurylink on this.

Attached please find a site plan and legal description. Initial fees in the amount of \$1300 will be submitted in person on February 7th or 8th.

Please be aware Public Service Company of Colorado owns and operates existing overhead electric distribution facilities located within the portion of the alley proposed to be vacated; therefore, we are able to give conditional approval,

PROVIDED, HOWEVER, said vacation shall be subject to the following reservations:

A perpetual, non-exclusive easement is hereby reserved by the City and County of Denver, its successors and assigns, over, under, across, along, and through the vacated area for the purposes of constructing, operating, maintaining, repairing, upgrading and replacing public or private utilities including storm drainage and sanitary sewer facilities and all appurtenances to said utilities. A hard surface shall be maintained by the property owner over the entire easement area.

The City reserves the right to authorize the use of the reserved easement by all utility providers with existing facilities in the easement area. No trees, fences, retaining walls, landscaping or structures shall be allowed over, upon or under the easement area. Any such obstruction may be removed by the City or the utility provider at the property owner's expense.

The property owner shall not re-grade or alter the ground cover in the easement area without permission from the City and County of Denver. The property owner shall be liable for all damages to such utilities, including their repair and replacement, at the property owner's sole expense. The City and County of Denver, its successors, assigns, licensees, permittees and other authorized users shall not be liable for any damage to property owner's property due to use of this reserved easement.

The property owner/developer/contractor must continue working with Katie Middleton on the design details of undergrounding or relocating the electric facilities.
