This contract reflects the Bureau of Justice Assistance, Office of Justice Programs, Department of Justice award to the Denver District Attorney's Office (DDAO) Denver Cold Case Collaborative. The award totals \$533,200.00 and the contract term is October 1st, 2023 – September 30, 2026. There is no match for the award.

The Bureau of Justice Assistance made these funds available to the DDAO through the Department of Justice Appropriations Act, 2023, which provides funding for state and local law enforcement agencies.

This award funds the salary of our Cold Case Attorney, travel and includes a subaward in the amount of \$208,500 to Denver Police Department over three years to support overtime for forensic scientists and detectives to decrease the number of unresolved violent crime cold cases awaiting prosecution.
