5 **To set a public hearing relating to the approval of an amendment to the**
6 **Welton Corridor Urban Redevelopment Plan to add the 2460 Welton Street**

14 **Section 1.** Date, Time and Location of the Welton Corridor Urban Redevelopment Plan
15 Amendment Public Hearing. The City Council shall conduct a public hearing on the amendment to
16 the Welton Corridor Urban Redevelopment Plan including the creation of the 2460 Welton Street
17 Project and the creation of the 2460 Welton Street Property Tax Increment Area. The public
18 hearing shall be on Monday, January 12, 2015, at 5:30 p.m. in Council Chambers in the City and
19 County Building located at 1437 Bannock Street, in Denver, Colorado.

20 **Section 2.** Other Notices. The Denver Urban Renewal Authority is requested to give all
21 written notices and publications required by C.R.S. § 31-25-107.

22 **Section 3.** Plan Amendment Submittal. That the Welton Corridor Urban Redevelopment
23 Plan amendment filed with the Denver City Clerk in City Clerk's Filing No. 2014-0955 on November
24 26, 2014, be submitted to the City Council and Board of Equalization of the City, sitting as the
25 Board of County Commissioners in accordance with the Charter of the City.

26 **Section 4.** That the Clerk of the City and County of Denver shall attest and affix the seal
27 of the City and County of Denver to this Resolution.
