WHEREAS, the property owners of the following described land, territory or real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

ALL OF THAT PARCEL OF LAND DESCRIBED IN SPECIAL WARRANTY DEED RECORDED AT RECEPTION NO. 2017066878,

CITY AND COUNTY OF DENVER CLERK AND RECORDER OFFICE, SITUATED IN THE NORTHWEST QUARTER OF SECTION 10, TOWNSHIP 3 SOUTH, RANGE 66 WEST OF THE 6TH PRINCIPAL MERIDIAN, WITHIN THE CITY AND COUNTY OF DENVER, STATE OF COLORADO.

PARCEL 2:

ALL OF THAT PARCEL OF LAND DESCRIBED IN SPECIAL WARRANTY DEED RECORDED AT RECEPTION NO. 2017097374,

LESS AND EXCEPT THE RIGHT OF WAY OF ARGONNE ST., DEDICATED TO THE CITY AND COUNTY OF DENVER AT RESOLUTION 0126, SERIES 2020 AND RECORDED AT RECEPTION NO. 2020028603,

CITY AND COUNTY OF DENVER CLERK AND RECORDER OFFICE, SITUATED IN THE NORTHWEST QUARTER OF SECTION 10, TOWNSHIP 3 SOUTH, RANGE 66 WEST OF THE 6TH PRINCIPAL MERIDIAN, WITHIN THE CITY AND COUNTY OF DENVER, STATE OF COLORADO.

THE ABOVE DESCRIPTION CONTAINS 147,678 SQUARE FEET OR 3.39 ACRES, MORE OR LESS

propose to lay out, plat and subdivide said land, territory or real property into a block and lots, and have submitted to the Council of the City and County of Denver a plat of such proposed subdivision under the name and style aforesaid, showing the adjacent streets and platted territory, accompanied by a certificate of title from the attorney for the City and County of Denver; and dedicating public utilities and cable television, and access easements as shown thereon; and

WHEREAS, said subdivision was surveyed by or under the direction of the City Engineer of

1 the City and County of Denver and said City Engineer has certified as to the accuracy of said survey
2 and said plat or map and their conformity with the requirements of Chapter 49, Article III of the
3 Revised Municipal Code of the City and County of Denver, and said plat has been approved by the
4 City Engineer, the Executive Director of Community Planning and Development, the Executive
5 Director of the Department of Transportation and Infrastructure and the Executive Director of Parks
6 and Recreation;

7 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**


8 **Section 1.** That the Council hereby finds and determines that said land, territory, or real
9 property has been platted in strict conformity with the requirements of the Charter of the City and
10 County of Denver.

11 **Section 2.** That the said plat or map of Denver Gateway Center Filing No. 8 and dedicating
12 to the City and County of Denver public utilities and cable television and access easements, as
13 shown thereon, be and the same are hereby accepted by the Council of the City and County of
14 Denver.
