The city has agreed to allow for a four-month temporary easement for the use of a portion of the southeast corner of the course, out of bounds and drainage area, for construction staging purposes needed for the construction of a pedestrian bridge. The easement area extends only 5' (five feet) into the golf course area and runs a length of approximately 590' (five-hundred and ninety feet) along the north side West Jewell Avenue.
