CR13-0985 A resolution levying upon all taxable property within the City and County of Denver taxes for the year 2013 for purposes authorized by law for School District No. 1 in the City and County of Denver, State of Colorado.

Levies upon all taxable property within the City and County of Denver taxes for the year 2013 for purposes authorized by law for School District No. 1 in the City and County of Denver, State of Colorado. Councilwoman Faatz approved filing this resolution.

CR13-0990 A resolution levying taxes for the year 2013 upon all taxable property within special districts within the City and County of Denver for purposes authorized by law for special districts.

Levies taxes for the year 2013 upon all taxable property within special districts within the City and County of Denver for purposes authorized by law for special districts. Councilwoman Faatz approved filing this resolution.

CR13-0951 A resolution approving the Mayor's appointments to the Denver Commission on Aging.

Approves the Mayoral appointments of Thomas Case, Cec Ortiz, Mayra Rosa, Maureen Spiegleman, Beverly Marcus Sunshine, and Janine Vanderburg to the Denver Commission on Aging for terms effective immediately and expiring August 31, 2015, or until a successor is duly appointed. The Committee approved filing this resolution by consent on 12-12-13.

CR13-0960 A resolution extending the award of \$23,000,000 of private activity bond volume cap allocation to the 2300 Welton Street Project.

Declares the intent of the City and County of Denver to issue an amount not to exceed \$23,000,000 of Multifamily Housing Revenue Bonds (Private Activity Bonds) for the 2300 Welton Street Apartment project in Council District 8. The Committee approved filing this resolution by consent on 12-12-13.

Land Use, Transportation & Infrastructure

CR13-0959 A resolution granting a revocable permit to Manuel Rocha to encroach into the right-of-way at 1629 Bruce Randolph Avenue.

Grants a revocable permit to Manuel Rocha to encroach into the public right-of-way with a porch, ramp, foundation, and a portion of the structure at 1629 Bruce Randolph Ave. in Council District 8. The Committee approved filing this resolution by consent on 12-12-13.

CB13-0882 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and AEG Live - Rocky Mountains, LLC, to promote and book concerts and live events at various City venues and facilities.

Approves a one-year, \$1,200,000 contract with AEG Live-Rocky Mountains to promote events at Denver Arts & Venues through December 2014 (THTRS-201313532). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill at its meeting on 12-11-13.

CB13-0883 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Bill Bass Concerts, Inc., to promote and book concerts and live events at various City venues and facilities.

Approves a one-year, \$225,000 contract with Bill Bass Concerts, Inc. to promote events at Denver Arts & Venues through December 2014 (THTRS-201313560). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill at its meeting on 12-11-13.

CB13-0884 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Dan Steinberg Presents LLC, to promote and book concerts and live events at various City venues and facilities.

Approves a one-year, \$50,000 contract with Dan Steinberg Presents, LLC to promote events at Denver Arts & Venues through December 2014 (THTRS-201313563). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill at its meeting on 12-11-13.

CB13-0885 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Live Nation Worldwide, Inc., to promote and book concerts and live events at various City venues and facilities.

Approves a one-year, \$500,000 contract with Live Nation Worldwide to promote events at Denver Arts & Venues through December 2014 (THTRS-201313558). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill at its meeting on 12-11-13.

CB13-0895 A bill for an ordinance approving a proposed First Amendment to Hotel Management Agreement (the Westin Denver International Airport) between the City and County of Denver and Westin DIA Operator, LLC related to development of an airport hotel at Denver International Airport.

Amends the Hotel Management Agreement between the City and Westin DIA Operator, LLC at Denver International Airport to update contractual deadlines and revise a restrictive covenant (CE0A072). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill at its meeting on 12-11-13.

CB13-0932 A bill for an ordinance approving a proposed First Amendment to Professional Services Agreement between the City and County of Denver and CH2M Hill Engineers related to land use and urban planning consultant services at Denver International Airport.

Adds 16 months and \$2,500,000 to the contract with CH2M Hill Engineers for planning services in support of the Airport City Denver initiative (201208805). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0957 A bill for an ordinance approving a proposed Airport Use and Lease Agreement between the City and County of Denver and Aerovias de Mexico, S.A. de C.V. for use of facilities at Denver International Airport.

Approves an Airport Use and Facilities Lease Agreement with Aerovias de Mexico S.A. de C.V. (Aero Mexico) for use of facilities at Denver International Airport to support the airlines operations (201209281). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 12-12-13.

Government & Finance

CB13-0850 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and Accela, Inc., to revise the Scope of Services, extend the term and increase the compensation.

Adds \$2,000,000 for a total contract amount of \$4,529,578.85 to the existing contract with Accela to replace the PILAR and Excise & License applications (CE06026). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill at its meeting on 12-11-13.

CB13-0852 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and Kronos Incorporated, to revise the scope of work, extend the term and increase the maximum contract amount.

Adds \$1,573,768.07 to the contract with Kronos, Incorporated, time keeping and payroll system (for a total contract of \$4,108,464.39) for additional maintenance services including police and fire (CE82121). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 11-14-13.

CB13-0861 A bill for an ordinance relating to Chapter 53 (Taxation and Miscellaneous Revenue) of the Revised Municipal Code, to standardize the confidentiality provisions for the taxes imposed in Articles II through VIII.

Amends the Denver Revised Municipal Code Chapter 53 Articles II, III, IV, V, VI, VII, and VIII (taxation sections) containing confidentiality provisions that limit access to account specific tax information to the Manager of Finance and employees. The ordinance change allows the Manager of Finance to approve access to the confidential tax information on a limited basis. The Committee approved filing this bill at its meeting on 12-11-13.

CB13-0866 A bill for an ordinance approving an Agreement between Engineering Economics, Inc. and the City & County of Denver for energy management services.

Approves a 3-year, \$1,500,000 contract with Engineering Economics, Inc. for on-call energy management services including energy audits, retro-commissioning, facility condition assessments, and technical support (GENRL-201313747-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 11-21-13.

CB13-0902 A bill for an ordinance approving a proposed Second Amendatory Agreement between the City and County of Denver and Global Tel*Link Corporation, to extend the term and revise the payment terms for the remainder of the term of the contract.

Extends the contract with Global Tel*Link for inmate phone services at the Denver Jail for three months through January 31, 2014 to accommodate a transition to a

new phone provider (RC85012). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 11-27-13.

CB13-0942 A bill for an Ordinance approving an Agreement for Grant of Easement with The George W. Clayton Trust, by its Trustee Clayton Early Learning, and Public Service Company for an easement located on the northerly edge of Park Hill Golf Course for relocation of electric transmission lines in furtherance of the construction of East Corridor FasTracks Project.

Grants a license (Park Hill Golf Course -Dahlia Street Underground Electric Line) between the George W. Clayton Trust, the City and County of Denver, and the Public Service Company for property located at Park Hill Golf Course. The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 12-5-13.

Health, Safety, Education & Services

CB13-0812 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and Populus, LLC to procure energy efficiency program support.

Approves a contract amendment for \$2,108,367 using American Recovery and Reinvestment Act (ARRA) grant funds for Populus, LLC which will provide loan program advising, customer support, data management, work flow management, energy advising, energy advisor training, and other project management support for the Denver Energy Challenge Program (ENVHL-201204731-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill on consent on 11-7-13.

CB13-0835 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and Denver Rescue Mission to provide emergency housing for homeless adults who are unable to stay in conventional shelters.

Amends the contract with Denver Rescue Mission to add \$175,200 bringing the contract total to \$963,600 to provide shelter and case management services for 300 adults who were discharged from hospital settings (CE04013-03). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 11-14-13.

CB13-0858 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Urban Peak Denver to provide housing units and case management services for eligible homeless youth in transition from foster care.

Amends the contract with Rocky Mountain Youth Housing program under Urban Peak Denver by adding \$256,280 for a total of \$512,560 and extending the term for an additional year through December 31, 2014 to provide 10 housing units and case management services for homeless youth in transition from foster care

(SOCSV 2013-09749 - 02). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 11-21-13.

CB13-0859 A bill for an ordinance approving a proposed Third Amendatory Agreement between the City and County of Denver and Warren Village, Inc., to provide housing and support services to homeless persons in the City and County of Denver.

Amends the contract with Warren Village to add \$177,500 for a total of \$710,000 through December 31, 2014, to provide housing and supportive services to homeless women and single parent families through the Warren Village First Step Program (SOCSV-CE11117-03). The last regularly scheduled Council meeting within the 30-day review period is on 1-13-14. The Committee approved filing this bill by consent on 11-21-13.

Land Use, Transportation & Infrastructure

CB13-0952 A bill for an ordinance designating certain properties as being required for public use and authorizing use and acquisition thereof by negotiation or through condemnation proceedings of temporary and permanent Easement interests, including all improvements, fixtures, licenses, permits, access points and any other rights and interests related or appurtenant to properties so designated for the Public Infrastructure (38th and Blake Station) TOD-Blake Street Bridge Project.

Authorizes an acquisition through negotiated purchase or condemnation of Temporary Construction Easements and Permanent Easement interests from property owners as part of the 38th and Blake Station Transit-Oriented Development-Blake Street Bridge project in Council District 9. The Committee approved filing this bill by consent on 12-12-13.

CB13-0955 A bill for an ordinance revoking the Major Encumbrance Permit granted by Ordinance No. 349, Series of 1979, and granting a new revocable permit to UBS Global Asset Management (US), Inc. to encroach into the right-of-way at 17th Street and Welton Street.

Revokes Ordinance No. 349, Series of 1979, and grants a new Ordinance to UBS Global Asset Management, which will include the improvements and area of the old encroachments of a drive-through canopy, as well as the new encroachments of a glass and metal curtain wall along 17th St. and Welton St. in Council District 8. The Committee approved filing this bill by consent on 12-12-13.

CB13-0887 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and The Superlative Group, Inc., to provide sponsorship sales and related services.

Approves a contract with The Superlative Group, Inc. through August 31, 2016 to sell an estimated up to \$30,000,000 in sponsorship opportunities for Arts & Venues Denver with the contractor paid via an annual \$75,000 professional services fee plus a percentage of the sponsorships sold (THTRS-201312921). Total contract is estimated up to \$7,725,000. The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill at its meeting on 12-4-13.

CB13-0896 A bill for an ordinance making a supplemental appropriation from the General Contingency Fund for a cash transfer to the General Government Special Revenue Fund.

Approves an expansion of the Metro Mortgage Assistance Plus Program to appropriate a supplemental amount of \$350,000 to the Down Payment Assistance Special Revenue Fund (11860-2550000) from General Fund Contingency as an administrative mechanism for the financial transactions related to this program. The Committee approved filing this bill at its meeting on 12-4-13.

CB13-0897 A bill for an ordinance making rescissions and appropriations in the General Fund and making a cash transfer to the General Government Special Revenue Fund.

Approves a Metro Mortgage Assistance Plus Program special revenue fund accounting true-up, to rescind \$400,000 of 2013 Department of Finance operational budget savings and reappropriate that amount to the "Metro Mortgage Assistance Plus Program" special revenue fund (11860-2550000) as an administrative mechanism for the financial transactions related to this program. The Committee approved filing this bill at its meeting on 12-4-13.

CB13-0917 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

Adds the classifications of Application Architect I (815-I) and Application Architect II (816-I) to the Classification and Pay Plan for city employees. The Committee approved filing this bill by consent on 12-5-13.

CB13-0918 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the

Career Service.

Changes the pay grades for Surveying Technician, Associate Surveying Technician, and Senior Surveying Technician in the Classification and Pay Plan for city employees. The Committee approved filing this bill by consent on 12-5-13.

CB13-0919 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

Changes the titles and pay grades of Tree Trimmer (611-J) to Arborist Technician I (614-J) and Senior Tree Trimmer (612-J) to Arborist Technician II (616-J) in the Classification and Pay Plan for city employees. The Committee approved filing this bill by consent on 12-5-13.

CB13-0920 A bill for an Ordinance approving an Agreement with Delta Dental of Colorado for dental insurance in 2013 for eligible city employees and classified members of the police and fire departments.

Approves an up to \$10,463,000 contract with Delta Dental of Colorado for dental insurance in 2013 to eligible city employees and classified members of the police and fire departments (CSAHR-201310007-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0921 A bill for an Ordinance approving an Agreement with Denver Health Medical Plan, Inc. for medical insurance in 2013.

Approves an up to \$4,500,000 contract with Denver Health Medical Plan, Inc. for medical insurance in 2013 for eligible city employees (CSAHR-201310658-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0922 A bill for an Ordinance approving an Agreement with Kaiser Foundation Health Plan of Colorado for medical insurance coverage in 2013 for eligible employees.

Approves an up to \$57,000,000 contract with Kaiser Foundation Health Plan of Colorado for medical insurance coverage in 2013 for eligible city employees (CSAHR-201309503-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0923 A bill for an Ordinance approving an Agreement with Kaiser Foundation Health Plan of Colorado for medical insurance coverage in 2013 for the Fire Department.

Approves an up to \$14,300,000 contract with Kaiser Foundation Health Plan of Colorado for medical insurance coverage in 2013 to eligible employees of the Denver Fire Department (CSAHR-201309544-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0924 A bill for an Ordinance approving an Agreement with Kaiser Foundation Health Plan of Colorado in 2013 for the Denver Police Department.

Approves an up to \$11,800,000 contract with Kaiser Foundation Health Plan of Colorado to provide medical insurance coverage in 2013 to eligible employees of the Denver Police Department (CSAHR-201309545-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0925 A bill for an Ordinance approving an Agreement with Standard Insurance Company for basic life insurance in 2013.

Approves an up to \$1,804,000 contract with Standard Insurance Company to provide life insurance in 2013 to eligible city employees (CSAHR-201310011-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0926 A bill for an Ordinance approving an Agreement with Standard insurance Company for short term disability in 2013 to eligible city employees.

Approves an up to \$2,310,000 contract with Standard Insurance Company to provide short-term disability insurance in 2013 to eligible city employees (CSAHR-201310012-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0927 A bill for an Ordinance approving an Agreement with United Healthcare Insurance Company for medical insurance coverage in 2013 to eligible city employees and Denver Police Department.

Approves an up to \$41,000,000 contract with United Healthcare Insurance Company to provide medical insurance coverage in 2013 to eligible city employees and eligible employees of the Denver Police Department (CSAHR-201310004-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0928 A bill for an Ordinance approving an Agreement with Standard Insurance Company for long term disability insurance in 2013.

Approves an up to \$747,000 contract with Standard Insurance Company to provide long-term disability insurance in 2013 to eligible city employees (CSAHR-201310017-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0933 A bill for an ordinance approving an Agreement between the City and County of Denver and Wells, Anderson & Race, LLC to provide special counsel legal services for conflicts cases, overflow and other matters as needed.

Approves a three-year up to \$1,000,000 contract with Wells, Anderson & Race, LLC to provide on-call special legal counsel and services (201313861-00). The last

regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0934 A bill for an ordinance approving an Agreement between the City and County of Denver and Hall & Evans, L.L.C. to provide special counsel legal services for conflicts cases, overflow and other matters as needed.

Approves a proposed Agreement between the City and County of Denver and Hall & Evans, L.L.C. to provide outside legal counsel services (201313859-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0935 A bill for an ordinance approving an Agreement between the City and County of Denver and Senter, Goldfarb & Rice, LLC to provide special counsel legal services for conflicts cases, overflow and other matters as needed.

Approves a three-year up to \$1,000,000 contract with Senter, Goldfarb & Rice, LLC to provide on-call special legal counsel and services (201313803-00). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0938 A bill for an ordinance to close various Special Revenue Funds.

Authorizes closing special revenue funds that are no longer being used and that have a zero cash balance. The Committee approved filing this bill by consent on 12-5-13.

CB13-0939 A bill for an ordinance making supplemental appropriations from the General Contingency Fund to Capital Improvement Funds (CIF) and Departments.

Approves year-end adjustments and supplemental appropriations for 2013, primarily for technology upgrades. The Committee approved filing this bill by consent on 12-5-13.

CB13-0941 A bill an ordinance approving an Electrical Equipment Permanent Easement from the City and County of Denver to DAM Office, LLC.

Grants an easement from the City and County of Denver to Denver Art Museum (DAM) Office, LLC to locate certain electrical equipment related to the construction of the new DAM offices on Bannock Street. The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

CB13-0943 A bill for an ordinance approving a proposed Purchase Order between the City and County of Denver and CenterPoint Energy Services, Inc., to provide Natural Gas Transport for the buildings of the City and County of Denver.

Approves a five-year up to \$50,000,000 master purchase order with CenterPoint Energy Services, Inc. for natural gas transport for city buildings (0366A0113). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

Health, Safety, Education & Services

CB13-0826 A bill for an ordinance approving a Fifth Amendatory Agreement by and between the City and County of Denver and Xerox State & Local Solutions, Inc., to increase the maximum contract amount and to extend the term of the agreement.

Approves a fifth amendment to the Xerox State & Local Solutions, Inc. contract to add one year through December 31, 2014 and to add \$150,000 for the continuance of the Automated Photo Red Light Program (CE-01061-05). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill on consent on 11-7-13.

Amends the contract with the Colorado Nonprofit Development Center to add one year through December 31, 2014 and to add \$543,283.50 to support jail to community reentry services (SAFTY-201208794-01). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill on consent on 11-7-13.

CB13-0931 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the Colorado Division of Criminal Justice concerning the "Crime Victim Compensation FY13" program and the funding therefor.

Accepts the annual federal Victim of Crime Act (VOCA) grant from the Colorado Division of Criminal Justice to augment the state funds available to the Crime Victim Compensation Program in the 2nd Judicial District in the amount of \$1,500,000 (201314089). The last regularly scheduled Council meeting within the 30-day review period is on 1-6-14. The Committee approved filing this bill by consent on 12-5-13.

Land Use, Transportation & Infrastructure

CB13-0940 A bill for an ordinance to appropriate the 2013 Revenue Based Winter Park Parks and Recreation Capital Fund.

Appropriates \$889,649 in the Winter Park Parks and Recreation Capital Fund due to the receipt of the 2013 Revenue Based Annual Payment per the terms of the existing Winter Park Lease and Operating Agreement. The Committee approved filing this bill at its meeting on 12-3-13.

CB13-0974 A bill for an ordinance relinquishing a portion of the easement reserved in Ordinance No. 38, Series of 1939, located at 458 Eudora Street.
Relinquishes a portion of the easement established in Ordinance No. 38, Series of 1939, at 458 Eudora in Council District 5. This bill was filed by Councilwoman Susman.

Special Issues: Amendment 64

CB13-0961 A bill for an ordinance de-criminalizing the offense of possession of marijuana by persons under the age of twenty-one.
Decriminalizes the possession of marijuana for people under the age of 21. The Committee approved filing this bill at its meeting on 12-9-13.

CB13-0963 A bill for an ordinance prohibiting certain behavior concerning marijuana from occurring upon any city-owned property within one thousand feet of any school.
Prohibits the consumption or display of marijuana on City-owned property, including streets and sidewalks, within 1000 feet of any school. The Committee approved filing this bill at its meeting on 12-9-13.
