

# Denver Parks and Recreation Fee Proposal September 2016

## Golf

- Last fee adjustment occurred in 2014
- Increases certain maximum green fee (applies to prime time play)
- Maintains Denver Golf's green fees in the lower end of comparable area courses
- Revenue is estimated to increase approximately \$250,000 annually
- Additional revenue will be use to address deferred maintenance and needed improvements

## Event Permitting

- Eliminate application fee (replaced by change to payment terms)
- Eliminate rain date fee (replaced by new cancellation policy)

## Event facilities

- Washington Park Boathouse & City Park Pavilion
  - Eliminate different pricing structure between events with and without alcohol
  - Increases prior "non-alcohol" fees to match "with-alcohol" fees
  - Adds 7 hour morning rate at City Park Pavilion
  - Retains 50% non-profit discount
  - Maintains Denver event facility fees at the bottom of comparable area venues
- Adds fees to the ordinance for the James Fleming Mansion
