6 **For an ordinance to amend the title of Ordinance No. 20160423, Series of 2016,**  
7 **which vacated the cross alley bounded by Hooker Street, Irving Street, West**  
8 **19<sup>th</sup> Avenue and West 20<sup>th</sup> Avenue, without reservations.**

9 **WHEREAS**, Ordinance No. 20160423, Series of 2016, approving a proposed alley vacation  
10 was enacted with an incorrect title; and

11 **WHEREAS**, the title of the Ordinance No. 20160423, Series of 2016, should read: “For an  
12 ordinance to vacate the cross alley bounded by Hooker Street, Irving Street, West 19<sup>th</sup> Avenue and  
13 West 20<sup>th</sup> Avenue, without reservations.”

14 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** The title for Ordinance No. 20160423, Series of 2016, is hereby amended to  
16 read “For an ordinance to vacate the cross alley bounded by Hooker Street, Irving Street, West  
17 19<sup>th</sup> Avenue and West 20<sup>th</sup> Avenue, without reservations.” The aforesaid title shall amend and  
18 replace the title reflected on Ordinance No. 20160423, Series of 2016.
