Monies received from the General Fund and Denver Human Services transfers or 19 other sources of receipts shall be deposited into the Treasury of the City and credited to Special 20 Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised 21 Municipal Code of the City and County of Denver. 22 Section 3. Expenditures are hereby authorized for the "Revolving Affordable Housing Loan" 23 fund Program, Accounting No. 16810-0145000, in the amount not to exceed the total of deposits 24 described in Section 2 of this Ordinance, to be expended by the Executive Director of Economic 25 Development. Authorized expenditures will include, but shall not be limited to providing gap 26 financing for the acquisition and rehabilitation of affordable housing units.
