Bill Requests

BR11-0263 Approves an amendment to Chapter 48 of the Denver Revised Municipal Code extending the solid waste program for the collection of compost material, charging residents for the service, and expanding to include DPS and municipal facilities as operational resources allow.

As part of Solid Waste Master Plan process, a study of Denver's waste material was performed. The largest component of our waste is compostable materials - food scraps and yard debris. It is important to maintain the composting program to keep as much of this material out of the landfill as possible.

Currently, Denver's composting program is still a pilot program in limited areas across the city (to provide data from a cross-section) and funded be user fees. Approximately 2,200 participants (about half the number of participants in the free program) are now paying \$9.75 a month for a large green wheeled bin, a small collection receptacle, and weekly pickup service. The fees are based on the cost of the service, which must completely be self-supporting.

A-1 Organics is the City's partner in the program, and they have a 90-day process that creates an excellent soil amendment material. This is primarily used for

agriculture, but some is made available to residents.

The proposed ordinance amendments continue the program in the existing limited program areas; provides for the charge to residents for the service, with a \$10 discount for payment in full up-front; removes the program sunset language; and provides an opportunity for DPS facilities located in the existing program areas to participate. The ultimate goal is to grow the program.

The annual fee is \$117. In 2010, the fee covered all cost for that year with \$175,000. The program has almost covered its costs for 2011, with 80% of participants paid in full, and the recruitment effort is being rolled out again in the program areas.

BR11-0258 Approves Text Amendment #7 to the Denver Zoning Code. Molly Urbina, Caryn Wenzara, Michelle Pyle and Michael O'Flaherty, Community Planning & Development

Zoning Code Text Amendment #7 was introduced to the Committee on March 29. The proposed amendments are primarily designed to 1) continue to improve the usability and organization of the code; 2) and to make clarifications and some substantive changes based on the experience of applying the code to actual situations for eight months now. Most of the presentation is the same as the March 29 presentation.
