- **SUMMARY:** Request for Ordinance to change and relocate a portion of the official channel of the South Platte River in Section 28, Township 4 South, Range 68 West, in the City and County of Denver, State of Colorado. The amended reach will be between West Evans Avenue and West Vassar Avenue. This change has been requested by the DOTI One Water group in conjunction with their development of rules and regulations designed to protect water quality in the South Platte.



A BILL

FOR AN ORDINANCE CHANGING, FIXING, DEFINING AND ESTABLISHING THE CHANNEL AND BOUNDARY LINES OF SOUTH PLATTE RIVER, IN SECTIONS 9 AND 28, TOWNSHIP 4 SOUTH, RANGE 68 WEST IN THE CITY AND COUNTY OF DENVER, AND PROVIDING FOR THE ACQUISITION OF THE LANDS NECESSARY THEREFOR.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER, THAT, WHEREAS, Chas. D. Vail, as Manager of Improvements and Parks of the City and County of Denver, heretofore did make and promulgate an Order in writing, which is in words and figures as follows:, to-wit:

"ORDER OF MANAGER OF IMPROVEMENTS AND PARKS.

It is hereby found and determined that the public use, necessity and convenience require that the official channel and boundary lines of South Platte River as fixed, determined and established by Ordinance No. 117 of the Series of 1910 of the City and County of Denver, be and the same hereby are changed and re-established in, thru, over and across part of Section 9, Township 4 South, Range 68 West of the 6th Principal Meridian so as to incorporate and consist of a strip of land 150 feet wide described as follows, to-wit:

WHEREAS, the location and construction of the limited access highway in the City and County of Denver known as the "Valley Highway" and the location, acquisition, and construction of rights of way and access rights required for said Valley Highway necessitate a change and relocation of that portion of the channel of the South Platte River in Sections 9, 15 and 16, Township 4 South, Range 68 West, hereinafter described, NOW, THEREFORE,

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That that portion of the channel of the South Platte River in Section 9, 15 and 16, Township 4 South, Range 68 West of the 6th Principal Meridian, in the City and County of Denver, State of Colorado, established by Ordinance No. 117, Series of 1910, between points in the east and west lines of said channel established by said Ordinance No. 117, Series of 1910, be changed to the following described area:

Beginning at a point in the west line of the channel of the South Platte River as established by Ordinance No. 117, Series of 1910, said point being a point of curve described in said ordinance located N. 18°35' W. 283.70 feet from a point in the south line of Section 9, T. 4 S., R. 68 W., 1,028.29 feet west from the southeast corner of said Section 9;

thence southeasterly along a curve to the left having a radius of 2,062 feet a distance of 271.85 feet to a point of reverse curve to the right having a radius of 750 feet;

This matter was discussed at Mayor-Council Meeting on April 12, 1955.


Also transmitted with this Bill is a map from the City Engineer's office indicating the area to be established as the channel by the terms of the proposed ordinance.


